US\$4,224,000 secured convertible debenture facility ('the Facility') interest rate of 8.0% p.a. of outstanding principal, repayment by way of 2% net smelter royalty. Indo Mines Limited ('the Company') has been advised that on 27 April 2018, completion of the acquisition of the Facility by Gladesburg Holding Ltd, a subsidiary of PT Rajawali Corpora ('Rajawali'), the Company's major shareholder from Anglo Pacific Group plc has completed.

At 31 March 2018 the Company has signed revolving credit facility Loan Agreements ('Loan Agreements') with Rajawali. Key terms of the Loan Agreements are principal amounts totaling US\$3,695,837, secured against a first priority payment on the sale of an interest in Sapex, interest of 7.5% p.a.
